

#### Dear Student:

Thank you for your interest in Xperitas' Financial Aid program. **Financial aid will be awarded on a rolling basis, so there may be an advantage to getting your application in early.** If your application is submitted after September 1, 2025, you must be enrolled in a program for consideration. **PLEASE DO NOT INCLUDE YOUR DEPOSIT CHECK WITH YOUR APPLICATION.** 

### Eligibility:

- 1. You must be a student (grades 6-12) registered on an Xperitas Immersion program.
- 2. Your family must meet the financial requirements as stipulated in the application.
- 3. You must complete the application requirements and have them submitted by October 15, 2025.

### Submission Requirements:

- 1. Section 1: Participant contact information.
- 2. Section 2: Household financial information and a photocopy of your parents' last Federal Income Tax Return. If your parents do not file jointly, both tax returns must be included.
- 3. Section 3: Additional Participant Information. (You may attach additional pages if needed)
- 4. **Section 4:** A **personal essay or video** (at least one page, double spaced if written) explaining why you want to participate in this Xperitas program and how you believe participation would help you be a better global citizen.
- 5. Section 5: A recommendation from an adult working at your school (teacher, coach, etc.).

**Important, please note!** It is the responsibility or the applicant to assemble your documents and submit them <u>in the same envelope</u>. Recommendations may be submitted under separate cover. *Xperitas is under no obligation to track down missing materials*.

#### Deadline:

All of the documents listed above must be postmarked no later than October 15, 2025. Only applications submitted in a timely manner will be considered.

#### Notification of Awards:

Participants who receive financial aid awards will be notified by email. Financial aid will be credited to your remaining balance **at the time of final billing**, approximately two weeks before the final payment deadline.

Awards are from 10 to 60 percent of the program price. All the information you submit will be taken into account when determining your award, including, but not limited to, your financial information, number of children in your family, your recommendation and personal essay.
